# Payments and Policies

## Deposit/Contract

To secure a date, a \$100 deposit + a digital contract is required. The deposit is non-refundable/ non-transferrable. The deposit will be applied to your wedding day. No wedding date is secure without both requirements even if a trial is scheduled for a future date.

## Payment

All payment is due after services are complete. Cash, Venmo, or Zelle are all accepted. Checks are not accepted

## Traveling fee

Traveling starts at \$150 which covers 50 miles or less from studio location (45567 Market St Shelby Township). Fee is subject to increase due to distance, hotel expenses, or extra needed stylists. Applicable parking fees will be added to the service total

## Late Fee/Cancellation

A late fee of \$25 will be charged for every 15 mins of delay when a client is late past the scheduled start time or for a scheduled appointment time.

Cancellations made 4 months or less from the wedding date will result in half the total amount charged.

Cancellations made 30 days or less will result in a total amount charged.

**Stylist must be notified of any changes to the requested services or number of people in the party 30 days before the wedding day. After that date, you will be responsible for the cost of all services listed in contract.**

## Miscellaneous

1. Lena Kacho cannot guarantee or be held accountable for any allergic reactions, or complications from the products or the application. Stylist is not liable to Client or any other third party for consequential, indirect, incidental, special, exemplary, punitive, or enhanced damages, arising out of, relating to, or in connective with any breach of this Agreement, regardless of (a) whether such damages were foreseeable, (b) whether or not Client was advised of such damages, and (c) the legal or equitable theory (contract, tort, or otherwise) upon which the claim is based. It is Clients' responsibility to secure insurance to protect themselves from unforeseen events or circumstances beyond the parties' control. Clients agree to relieve and hold Company harmless for all such circumstances.
2. Any photos taken by Stylist on the day of wedding can be used for their own promotional use on website and/or social media.
3. Since clients have every opportunity to address issues with hair during their service, Stylist is not responsible for any hair issues/damages after the service is complete. This includes damages due to weather, playing with hair, movement, or hair changes. Any corrections will be made at the very end if time allows and will result in an additional \$25 charge. A complete redo will result in the full amount charged.
4. If it is requested for stylist to stay past the finish time, there is a \$50 per hour charge
5. If Stylist feels unsafe or mistreated at any time, we reserve the right to refuse/terminate the service immediately.

## Safe Working Environment

During the ongoing COVID-19 pandemic, the Company continues to maintain a safe and clean work environment at all times, consistent with all health and safety laws. If anyone in the party is experiencing symptoms of COVID-19 or has recently tested positive for the virus, services will not be provided to them.

All payments and services are NON-refundable. In cases of an emergency situation, a full refund will be returned to the Client.
